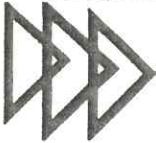

Outlets available as listed below, are stated according to wattage or amperage, (120 Watts equals one amp.) The costs are based upon ALTERNATING CURRENT ONLY, 115 volts, 60 cycles. One outlet (any size), consists of a duplex receptacle. Power (208 volt, 1 and 3 phase) available as listed below, is stated according to horsepower and amperage. Power lines come furnished with a fused disconnect switch only. Larger power lines can be supplied at an additional cost, which can be estimated by phoning our office with specifics.



Before ordering electrical services, determine exactly how much wattage or amperage your equipment draws. If your equipment draws more power than what you have ordered, you will be charged full show price for the size outlet you actually need. There will be no refunds for any undersized outlets previously ordered.

It is imperative that you order the proper size outlets to avoid being inconvenienced during show hours by Lighting & Decorating officials.

**GENERAL CONDITIONS:**

A SEPARATE OUTLET MUST BE ORDERED FOR EACH PIECE OF EQUIPMENT TO BE CONNECTED THAT DRAWS 500 OR MORE WATTS. THIS DOES NOT APPLY TO LIGHT BULBS.

CUSTOMER WILL BE RESPONSIBLE FOR FULL PAYMENT OF CHARGES AFTER INSTALLATION REGARDLESS OF USAGE.

All orders must be received five days prior to show or they will be considered as late orders and subject to floor price.

The Electrical General Foreman is obligated to refuse connections where wiring is not in accordance with the Board of Fire Underwriters.

All complaints must be presented by the exhibitor before the close of the exposition in order to be properly investigated.

Lighting & Decorating Co. cannot be responsible for any damages to customer's equipment due to fluctuating voltages in the convention area.

Service will be supplied to equipment in the most convenient manner. Each outlet supplied has a standard three-pronged receptacle; it shall be the responsibility of the exhibitor to supply any adaptors which may be necessary. Each motor of 3 HP or more must be equipped with fusible switch.

To facilitate installation, exhibitor must have all specific requirements available.
